## COVID-19 Rules

- Follow social distancing in the classroom and around the school.
- Stay with your parent at all times until you are inside the school building
- Wash your hands, on entry to school
- Do not ride a bike or scooter in the school grounds
- Follow the new route to your classroom
- Stay with your class at all times. You will need permission to leave the classroom and will be escorted by an adult
- Only use the resources in your zip wallet unless directed by an adult to do differently. Do not share any food or drinks at break times
- Sit in your designated space only unless directed by an adult to do differently
- Stay in your designated areas of the playgrounds at break and lunch times
- Wash your hands regularly and sensibly for at least 20 seconds using soap and water
- Follow the new hygiene rules if you sneeze or cough 'catch it, bin it, kill it' using the new lidded bin
- Avoid touching your mouth, nose and eyes with your hands. If you do ask permission to wash your hands immediately
- Cover your mouth if you cough or sneeze and ask permission to wash your hands immediately
- Use the toilet appropriately and sensibly flush the toilet after use, wash your hands and avoid splashing water
- Do not spit or lick
- If you see anyone not following the new rules above tell your class teacher or another member of staff immediately.
- Tell your teacher immediately if you feel unwell

All usual behaviour systems will be in place e.g. rule reminders, penalty points. Golden Time will still take place, but appropriate to the social distancing rules.

The following will need to be acted on appropriately considering the <u>age, maturity and individual needs</u> of the child concerned:

In class - Children to remain seated in class. However, if a child is not sitting the adult will follow these steps:

- (Step 1) Calmly remind the child to sit down
- (Step 2) Repeat 'You need to sit in your seat or you will not be allowed to stay in the classroom'.
- (Step 3) A senior member of the leadership will be notified and a decision will be made. This may involve the parent / carer being asked to collect the child, due to health and safety.

Around the school or in the playground – Social distancing to be maintained. However, if a child is not adhering to this, the following steps will be followed:

- (Step 1) Calmly remind the child to stay away from others, demonstrate this if the child is unclear.
- (Step 2) Repeat 'You need to stay away from others'. Again, demonstrate this if the child is unclear.
- (Step 3) A senior member of the leadership will be notified and a decision will be made. This may involve the parent / carer being asked to collect the child due, to health and safety.

Antisocial behaviour related to Covid (e.g. coughing without covering their mouth) – as above.

Any extreme behaviour or repeated instances of not following the new systems, will be reported immediately to the leadership team, who will act considering the well-being and safety of all

concerned. If a pupil cannot follow the above rules and is putting others at risk, they will not be allowed to attend Roding Primary School.
